BY JOINING THIS PROGRAM AND PROMOTING OUR ONLINE PRODUCTS, YOU ARE AGREEING THAT YOU HAVE READ AND UNDERSTAND THE TERMS AND CONDITIONS OF THIS AGREEMENT AND THAT YOU AGREE TO THE CONTENTS.

OVERVIEW

This Agreement contains the complete terms and conditions that apply to you becoming an affiliate in Unreplaceable's Affiliate Program. Please note that throughout this Agreement, "we," "us," and "our" refer to Unreplaceable and "you," "your," and "yours" refer to the affiliate.

AFFILIATE AGREEMENT

By filling out and submitting the signup form you will automatically become an affiliate and are bound by the terms of this agreement. Your participation in the program is solely for this purpose: to legally advertise our website to receive a commission on products purchased by your referral individuals.

AFFILIATE OBLIGATIONS

While there is no approval process, there are conditions that must be met.

You must be at least 18 years of age and own the digital properties and social accounts you represent.

We may cancel your agreement if we determine that your site is unsuitable for our Program, including if it:

- Promotes sexually explicit materials
- Promotes violence
- Promotes discrimination based on race, sex, religion, nationality, disability, sexual orientation, or age
- Promotes illegal activities
- Incorporates any materials which infringe or assist others to infringe on any copyright, trademark or other intellectual property rights or to violate the law
- Is otherwise in any way unlawful, harmful, threatening, defamatory, obscene, harassing, or racially, ethnically or otherwise objectionable to us in our sole discretion.

You may not create or design your website or any other website or social media profiles you operate, explicitly or implied in a manner that resembles our website or in a manner that leads customers to believe you are Unreplaceable.

You will not misrepresent your relationship with Unreplaceable in any way.

You will abide by all other third-party website's (e.g. social media) policies on affiliate links and referral advertising.

AFFILIATE OBLIGATIONS CONTINUED

You will not engage in any search or display advertising or bid on keywords that contain any of our intellectual property or trademarks.

All affiliates are especially not allowed to use Unreplaceable or beunreplaceable.com or our trademarked name in any non-affiliate URL or any online ads or copy.

You will not purchase or have any ownership of any domain names, digital properties or keywords that contain any of our intellectual property or trademarks.

This is not an exhaustive list of prohibited advertising behaviours, and we reserve the right to remove you as an affiliate at any time.

AFFILIATE LINKS

You may use the graphic and text links provided to you on your website, emails and social media channels.

AFFILIATE TRACKING

When a user visits our website through your affiliate link, a cookie is set in their browser that contains your affiliate username. Also, their IP address is tracked in the database along with your affiliate name. When this person decides to buy a product, the script will look for this cookie and/or try to match their IP address to identify the affiliate who will be awarded the commission. Visitors sent through your affiliate link may make a purchase later in time (up to 30 days) and the commission will still be awarded if the cookie is present in their browser and/or they are using the same IP address as the one logged in the database.

OUR RIGHTS AND OBLIGATIONS

We may notify you of any changes to your site that we feel should be made, or to make sure that your links to our web site are appropriate and to notify you of any changes that we feel should be made. If you do not make the changes to your site that we feel are necessary, we reserve the right to terminate your participation in the Affiliate Program.

We reserve the right to terminate this Agreement and your participation in the Affiliate Program immediately and without notice to you should you commit fraud in your use of the Program or should you abuse this program in any way. If such fraud or abuse is detected, Unreplaceable shall not be liable to you for any commissions for such fraudulent sales.

LIABILITY

We will not be liable for indirect or accidental damages (loss of revenue, commissions) due to affiliate tracking failures, loss of database files, and any results of "intents of harm" to the program or our website. We do not make any expressed or implied warranties with respect to the affiliate program and/or products sold at this site. We make no claim that the operation of the affiliate program and our website will be error-free and we will not be liable for any interruptions or errors.

AFFILIATE AGREEMENT

AFFILIATE PAYMENTS

- All our payments are made via Paypal in USD
- All potential referrals and subsequent sales are tracked via cookies which are set to a 30-day expiration ('Cookie Period').
- Your commissions are calculated and paid only on verified sales made during this Cookie Period.
- This means that you as an affiliate can receive a commission for a verified sale if the sale was made within 30 days of the user clicking your affiliate link
- Payouts will be distributed approx 30 days from the end of the month the purchase was made. For example: Affiliate payments attributed to purchases from June will be paid out around the 1st of August.
- The time from approval of a payout to funds deposited in your bank account is subject to PayPal
- To be eligible for payment, you need to have an active PayPal account synced to your affiliate account.
- Commissions are not paid on sales that are cancelled or refunded (within our 30day refunded window)

MODIFICATION

We may modify any of the terms and conditions in this Agreement at any time at our sole discretion.

Modifications may include but are not limited to, changes in the payment procedures or the affiliate program rules. Your continued participation in the program following the posting of the change notice or new Agreement on our site will indicate your agreement to the changes.

PROMOTION RESTRICTIONS

You should know that certain forms of advertising are always prohibited. For example, advertising commonly referred to as "spamming" is unacceptable to us and could cause damage to our name.

If it comes to our attention that you are spamming, we will consider that cause for immediate termination of this Agreement and your participation in the Affiliate Program. Any pending balances owed to you will not be paid if your account is terminated due to unacceptable advertising or solicitation.

PREPRESENTATIONS AND WARRANTIES

You represent and warrant that: You have the full right, power, and authority to enter into and be bound by the terms and conditions of this Agreement and to perform your obligations under this Agreement, without the approval or consent of any other party; You have sufficient right, title, and interest in and to the rights granted to us in this Agreement.

MISCELLANEOUS

You agree that you are an independent contractor, and nothing in this Agreement will create any partnership, joint venture, agency, franchise, sales representative, or employment relationship between you and Unreplaceable will have no authority to make or accept any offers or representations on our behalf.

If any provision of this Agreement is held to be invalid or unenforceable, the remainder of this agreement shall have full force and effect.
